1. Reason for Introduction of Executive Officer System

The Executive Directors will be the candidates to manage the company in the next generation, and will manage and supervise divisions which are important to our business, and also partially participate in making important decisions in management.

2. Outline of the System

- (1) The term of office of the Executive Officers will be one year.
- (2) The appointment and discharge of Executive Officers will be made by the Board of Directors.

3. Timing of Introduction of the System

The System shall be introduced from July 1, 2008. Changes of Directors are contingent upon a resolution to be passed at the 19th General Meeting of Shareholders held on June 23, 2008.
